OSF Premiums (prize money) will not be paid to classes not requiring OSF paid class entry fees, nor in classes ineligible for prize money/premium payment per association or breed registry rules.

1. Every POA entered in this show must be measured unless a legible copy of the Permanent Height Card or Official Measurement Card is included with the entries. The exhibitor is responsible for presentation of the pony's permanent height card to the measurement team. Measuring can be accomplished between on Saturday, Sept. 26 afternoon/evening, and on Sunday, Sept. 27 prior to the start of the show. Check with Jan Jones Nolen for exact time and location.
2. Classes listed herein as divided by height may be combined if there are fewer than three (3) entries in each division.
3. All Futurity entrants must pay entries for and enter their respective/corresponding OSF classes on the OSF entry forms. Even though you do not need to pay entry fees for the Futurity classes to the OSF, it is mandatory that you also indicate the class number for the futurity class(es) you have entered on the OSF entry form.

1. Miniature Donkey classes will be held in accordance with the MMDBA rules/regulations unless otherwise superseded by Oklahoma State Fair show/rules and/or stated herein.
2. Classes for Miniature Donkeys will be co-sanctioned by the International Mule and Donkey Association, LLC and IMAD will award \$50.00 to the Hi-Point Miniature Donkey and \$25.00 to the Reserve Hi-Point Miniature Donkey with an additional \$100.00 awarded if the animal is registered with IMAD and the exhibitor is a current year member of IMAD. Onsite registration will be available, but for early registrations, contact IMAD information source provided above.
3. All Miniature Donkeys must be registered within at least one of the following registries/associations: ADMS, IMDR, ACOSA or IMAD.
4. Maximum height for animals entered in the Miniature Donkey classes is 36".
5. Miniature Donkeys must be at least two (2) years old to participate in harness classes and at least three (3) years old to participate in Coon Jump and In-Hand Jumping.
6. Eligibility for age specific halter/in hand classes will be determined by actual date of birth of animal and date of scheduled/entered class.
