5D Entry Fee Per Horse: \$35.00  
Exhibitions: \$ 4.00/per run  
AQHA Approved Classes: \$15.00/per class/per horse (Youth, Amateur, Junior & Senior Classes)

**AQHA entries REQUIRED to pre-enter by August 28, 2009.**

Provide copies of current AQHA Memberships for Owner/Rider,  
as well as Copy of Horse Registration with each entry.

Stalls (Mandatory): \$25.00/per horse (Stall Check In Wed Noon–10pm or Thursday;  
Check Out 10am Fri)

*Stalls are mandatory for all Oklahoma State Fair Horse Shows. No tie outs permitted due to public access in parking areas during the State Fair and EPA requirements (no exceptions).*

*Also you will be required to pay at the gate to get into the fair as do all horse show exhibitors. This year's barrel race falls on Opening Day and features \$1 gate admission per person. Come in the morning and spend the entire day at the State Fair with the entire family and some friends for only \$1 each!*

*Check In Reminder...All Horses must enter thru Gate 7. This is OPENING weekend and the OSF's biggest horse/livestock weekend which includes the Draft Horses and Livestock Shows. There will no doubt be LONG lines at the Horse/Livestock Inspectors gate. We would encourage barrel racers to come in Wednesday for easier check in (no gate admission on Wednesday). However if you come in on Thursday, please allow plenty of time to go through the process.*

**PRE-ENTRY FORM (POSTMARKED BY August 28, 2009)** will be posted on [www.oklahomastatefair.com](http://www.oklahomastatefair.com) and [www.trikbarrels.com](http://www.trikbarrels.com) by no later than July 1, 2009. There are no late fees, but pre-entries will get the first draw positions available. Also, Oklahoma State Fair General Requirements for all horse shows will be in effect so please check their website for more information.

AQHA classes will carryover times from Open 5D. Each AQHA Entry is an additional \$15 per class/per horse. Pre-Entries Not Accepted for Exhibitions (sign up day of show) **On-Site Entries are CASH ONLY!!!** Be prepared to show both Health Papers and Coggins at perimeter gate on ALL horses – State Livestock Inspectors will be checking them....guaranteed. All Oklahoma State Fair Horse Show exhibitors must pay admission at perimeter gates.
