RULES:

- Heifers may be entered in the open show by paying entry fees and buying an Exhibitors Admission Pack.
- The heifer must be registered in the name of the Junior exhibitor prior to July 1 of the current year.
- All Hereford entries must be duly recorded with the American Hereford Association.
- Any animal with a pending or applied for registration or without a legible tattoo will not be eligible for show competition.
- All entries are subject to provisions and rules for showing as set forth by the American Hereford Association Board of Directors, and are subject to supervision of the Show and Sale Committee representing the AHA.
- All (Horned and Polled) Hereford Cattle will show together.
- **Exhibitors must show in clean pressed jeans, clean shirt with collar and club emblem (4-H or FFA). 4-H and FFA jackets are acceptable but not required. T-shirts, tennis shoes, and headwear are not allowed.**
- All accounts of owner must be in financial good standing to be eligible to enter the show ring. Any and all monies will be applied to entry and show fees before being applied to exhibitor admission tickets.

PREMIUM INFORMATION:

- The Oklahoma Hereford Association and the Oklahoma State Fair® (OSF) offer premiums in this division jointly.
- The Associations portion of premiums will be paid directly from the Oklahoma State Fair®.
- Premiums will be paid in all classes except division and overall championship classes.
- Premium Scale: \$45, \$35, \$25, \$15, \$5

ENTRY INFORMATION:

- Owner's W-9 form must be included with entry.
- Entries can be made online or mailed in. Online entries close August 15. Credit Card payments only taken online.

FEES:

Required

- \$25.00 per head (if postmarked or entered online by August 15)
- \$50.00 per head (if postmarked after August 15 & by September 1)
- \$5.00 processing fee per Division (example, if showing junior heifers, breeding swine and market sheep total would be \$15.00 in processing fees)

Additional

- Equipment permit
- Additional Tickets (pre-order for immediate family members) \$7.00 adult single day ticket, \$4.00 child single day ticket (ages 11-6) if postmarked by September 1, 2009. Also may purchase Season Pass for \$23.00 good for all 11 days.
- Exhibitor will receive complimentary Exhibitor Book of 4 Gate tickets good for 4 days with Junior Entry.

GENERAL RULES AND REGULATIONS:

- Exhibitor agrees to abide by all rules, regulations, specifications and requirements set out in the General Rules and Regulations section (found separate from this section) and any other said rules distributed by OSF management.

Classes:

- Classes will be broken after arrival and check-in at the show.
- Heifers born on or after September 1, 2007 are eligible to show.
- There will be one bred and owned class at the conclusion of the Owned Show. To be eligible, heifers must have been exhibited in Owned Show.
